## **Dunn-Edwards "Roller Club" Painting Contractor Sweepstakes Official Rules**

The prize includes free shipping and handling to the winner's designated address within a 100-mile radius of Sponsor's Cotati, CA store location, and the prize winner will not be responsible for any prize-related sales tax. The prize winner must have a Sponsor purchasing account and will receive a credit to his/her Sponsor purchasing sub-account to order up to \$1,000 of roller covers in quarterly increments of up to \$250 (during each of July-Sept. 2023, Oct.-Dec. 2023, Jan.-March 2024, and April-June 2024). The approximate retail value ("ARV") of the Sweepstakes prize is \$1,000. The winner must place all orders using his/her Sponsor purchasing sub-account and through his/her Sponsor sales representative. The sub-account number will be provided by Sponsor. ENTER THE SWEEPSTAKES. The Sweepstakes winner will be selected and announced via a random drawing at approximately 1 pm on Tuesday, June 27, 2023 from among all eligible tickets contained within the designated box at the Cotati Pro Show. The winner will be notified in-person if present at the drawing or within 24 hours via email, text or phone call. The drawing will be conducted by a Sponsor representative, whose decisions will be final and binding on all matters relating to the Sweepstakes. Odds of winning depend on the number of eligible entries received prior to the drawing time; 633 postcards were mailed to potentially eligible entrants. Entrants must be at least twenty one (21) years of age or older at the time of entry. All employees, sales representatives, licensees, or agents of Sponsor or any of its affiliates (collectively, "Sponsor Persons"), the immediate family members (spouse, parent, child, sibling, and their respective spouses) of any Sponsor Person, and all persons living in the same households as any Sponsor Person (whether legally related or not), are ineligible to enter or win the Sweepstakes. All applicable federal, state, and local laws and regulations apply. Void where prohibited by law.

- **PUBLICITY:** As a condition of entry into the Sweepstakes, except where prohibited by law, each entrant, and each potential prize winner by accepting a prize, grants to Sponsor a perpetual, worldwide, royalty-free license and right to publicize, broadcast, display, and/or otherwise use the Sweepstakes entrant's name, city and state of residence, and biographical material in any media now known or hereafter devised throughout the world in perpetuity for advertising and publicity purposes, without additional review, compensation, permission, or approval.

intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who is responsible or who tampers with the entry process or otherwise acts in violation of these Official Rules, and to cancel, modify, or terminate the Sweepstakes. In the event of cancellation, Sponsor will award the prize in a drawing from among all eligible, non-suspect entries received prior to cancellation. In the event that an entry is confirmed to have been erroneously deleted, lost or destroyed, entrant's sole remedy will be another entry into the Sweepstakes or a future sweepstakes.

- 11. All issues and questions concerning the construction. validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the entrants and Sponsor in connection with the Sweepstakes, will be governed by, and construed in accordance with, the laws of the State of California, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of California.
